EUROPEAN NEIGHBOURHOOD POLICY REVIEW AND ITS PRIORITIES FOR THE ASSOCIATED COUNTRIES

Since the Eastern Partnership (EaP) initiative was launched in 2009, it has gone a long way in shaping the agendas of bilateral and multilateral cooperation between the EU and its partner countries. In 2014, Georgia, Moldova, Ukraine reaffirmed their European choice, signed the Association Agreements with the EU and recognized their aspiration for the EU membership. The Agreements brought bilateral cooperation between the parties to a new level. To the different extent, the associated partners have made significant progress in implementation of political and economic part of the Association Agreements, including Deep and Comprehensive Free Trade Areas and Visa Liberalisation Action Plans. Differentiation in ambitions and interests of the EaP countries toward partnership with the EU was one of the reasons for the European Neighborhood Policy review. Keeping integrity of the EaP initiative, especially on multilateral level remains one of the priorities for the EU and its partner countries.

THE MODERN SECURITY ARCHITECTURE: CHALLENGES AND OPPORTUNITIES

Introductory video: "Life with Barbed Wires"

The speed of the disintegration of the post-cold war European security architecture is truly alarming. Russian military interventions - Georgia in 2008 and Ukraine in 2014, occupation of Georgian regions of Abkhazia and South Ossetia and of Crimea in Ukraine, the on-going war in the Eastern Ukraine are indicators leaving no room for uncertainty that a new security structure is being forced upon the European Continent. Russia is skilfully using all the means of hybrid warfare including information war, energy dependency leverage and political lobbying in order to question the concept of the European cooperative security. With the view of resolving the current crisis and increasing cooperation and stability in the region the European security strategy needs to incorporate more coherent policies and new forms of addressing existing challenges.

"BREXIT" AND T	THE FUTURE OF EUROPE (Chatham House Rules)

The British people voted to leave the European Union by margin of 52% to 48%. As a next step, according to the Article 50 of the Treaty of European Union, in the coming months and years, British and European leaders will have to negotiate the terms of UK's exit. Despite the fact that it might take years for the full consequences to be clear, some of the challenges became evident immediately including the British pound plunging 10 percent and Leaders from Scotland and Northern Ireland calling for referendums of their own to leave the UK. Furthermore, BREXIT had spill over effect across Europe as Eurosceptic politicians in Italy, France, The Netherlands and Denmark all called for similar referendum.

It is not a mere tool for long term policy planning, rather, modern strategic communication became the only effective mechanism of countering deceptive messages, falsified facts and distorted realities. In order to effectively address contemporary challenges affecting European peace and stability it is necessary to improve strategic communications at the European level, enhance information and experience sharing mechanisms, develop common positions, create a network of public diplomacy experts and engage in more robust communication strategies to fight growing anti-western propaganda.

DEEP AND COMPREHENSIVE FREE TRADE AREA: LEGISLATIVE REFORMS AND ECONOMIC IMPACT

One of the important components of the EU-Georgia Association Agreement is the Deep and Comprehensive Free Trade Area. DCFTA aims at integrating Georgia's economy into the EU economy through the legal approximation in the field of trade and trade related area. For the gradual and effective realization of the DCFTA, the Government of Georgia approved 2014-2017 Action Plan for implementation of the DCFTA. Since 2015, issues related to the DCFTA are also considered in the National Annual Action Plan for implementation of the Association Agreement. Implementation of the DCFTA will support and promote development of an investment climate and business environment in Georgia. At the same time, implementation of the DCFTA provides Georgia with possibilities to become an export platform to the EU for the countries which do not have free access to the European market.

The EU was one of the first to assist Georgia in the difficult early years of transition and since then it annually provides substantial financial assistance supporting Georgia's process of democratization and development. By signing the Association Agreement in 2014, Georgia's relations with the EU reached qualitatively new and higher level. European integration became an integral part of the country's domestic policy creating a solid basis for the Georgia's "European Way". In this context, EU assistance has a special role in the process of implementation of the Association Agreement and particularly in the process of reforms in the Rule of Law and Judiciary sectors. In the light of successful implementation of the reforms, the amount of the EU financial assistance and the support delivered by the EU Member States and other donor organizations has significantly increased, as well as new and more comprehensive EU assistance instruments has become available for Georgia.
